CAPITAL's baseline emissions are taken from 2024-2025 financial year with January, February and March tCO<sub>2</sub>e estimated based on the monthly total average of tCO<sub>2</sub>e for April to December 2024.

Future tCO<sub>2</sub>e reports will be collected by the end of each financial year.

There has been no historical reporting on CAPITAL's carbon emissions prior to this period.

The baseline period will include reported emissions in Scope 1, Scope 2 and Scope 3.


## **Emissions Reduction Targets**

CAPITAL will aspire to achieve Net Zero by 2045 (as mandated by the NHS and its procurement of contracted services).

CAPITAL will investigate options to reduce the emissions produced by transport activities via cars by encouraging staff to adopt public transportation methods where possible as it relates to the charity's activities.

Additionally, CAPITAL will endeavor to reduce tCO<sub>2</sub>e produced by transport activities via cars by 2 tCO<sub>2</sub>e by 2026 which will constitute 11% decrease of tCO<sub>2</sub>e produced by transport activities via cars and a 6.29% reduction of total tCO<sub>2</sub>e.

Furthermore, CAPITAL will begin to develop internal policies to ensure the reduction of carbon producing activities which does not impact on the daily operational activities of the organization but is scaled with the size of the organization, employees and funding for charitable activities.



The line graph below will show the current  $tCO_2e$  produced by CAPITAL for 2024-2025 and the future ambition to reduce  $tCO_2e$  between 2025-2026.
